Meeting Minutes: August 08, 2023

1. The meeting was called to order at 7:pm

2. Pledge of allegiance was said by all present.

3. Approval of Amended Agenda to include under new business. 3 items 1. (trash) 2. (bathroom) 3. (Reading room). Steve Keller made motion. Howard Wood seconded all in favor motion carried.

5. Financial reports: overall Total \$257,356.89

6. Payment of bills: Bills Totaling \$ 17,611.21 Maria Affhalter made motion to pay bills Steve Keller seconded, all in favor bills will be paid.

7. Correspondence/announcements: Treasurer noted that the township received a letter from Local community stabilization stating that they made an error and overpaid in May 2023 the amount over is \$987.03, this over payment will be corrected in the May 2024 Metro payment. Supervisor announced that Doug Craven from the Little Traverse Bay Band will be attending the next township meeting to talk about rules at the campground.

8. Public comments: Ron Brown doesn't like the CVCC open all night. Gets loud at night, at 2 or 3 in the morning. People want donated chair to go to the dump. Slamming doors at all hours of the night. Girl from legs inn was living here. Donna Wood: used excessive amounts of toilet paper, soap and paper towel. Rose Stated the second night she was here she heard a woman screaming at 1 am. Joann suggested more cameras. Tanya: Public restrooms proper signs. Would let township put porta potties on her land. Joan: porta potty behind red path church, used by many other people.

A lady from Cross Village Shores asked us to look into fire works after 10pm on grape hill who owns grape hill?? The supervisor will investigate the owners' association for her. Back to homeless people living in this area. She? Said she talked to Kathy Smolak the girl they fired was staying a few days in area.

9. committee reports: The Recreation committee plan to have meetings the Tuesday after the township meetings.

10. Unfinished Business:

1. Pickleball courts, off agenda

2. ARPA funds project: cannot pave the recycling area. The old town hall improvements: The tribe may help with getting grants and preserving it as a historical building. Diana Keller Motion to contract tribe regarding renovation of town hall. Steve Keller seconded. All in favor motion passed.

11. New business:

1. SLFRF agreement with Emmet County Steve Keller made Motion to accept Marie Garrett seconded A roll call vote all were in favor the roll call was 5 yes.

2. Men’s room needs a new toilet. Diana Keller made motion to spend up to \$500.00 Steve Keller seconded A roll call vote taken all in favor 5 yes.

3. Little Travers Disposal: the cost for two totes for seasonal use \$70.00

4. Reading Room unlocked 24 hours: The board members took a Roll call vote 4 were in favor of leaving the front door unlocked 1 was against leaving the door unlocked.

12. Second Public Comments: This is the Town Hall, what are we going to do about people walking in and out of here. What are normal library hours. What is reason for leaving it open? Ron said local people aren’t the problem. Went over there, A lot of people making noise and drinking. A man threatened him, at 11:30 at night. Ms. Brown stated that a female board member cursed at her husband. She apologized for her behavior.

Joan ask what the insurance would say about the building being open overnight.

Notes: Marie Garrett will pick up a new life ring. Howard Wood stated the new furnace would cost about 1,800.00 not including the installation of furnace.
